MINUTES OF THE 2021 ANNUAL GENERAL MEETING Thursday 21 October 2021 10.00am - 11.00am

1. Meeting opening

TTNQ Chair, Ken Chapman, declared the AGM open at 10:08am, welcoming: Cairns Regional Council Mayor, Bob Manning; Tara Bennett, Tourism Port Douglas Daintree; Board directors; members; and guests.

- On behalf of the Board; our members and the whole community, for their efforts and dedication on our behalf.
- Special thanks to Cairns Regional Council and Mayor Bob Manning for recognising the economic importance of tourism, increasing revenue for TTNQ, guaranteed into the future.
- Cairns Airport and Ports North and Local Tourism Organisation's (LTO's) and our supportive members.
- The Finance, Audit & Risk Management Committee (FARMC); Greg Nucifora as Chair, Wayne Reynolds
 as Deputy Chair, Jeff Gillies and Luckbir Singh. Lukbir has foreshadowed his intention to stand down
 this year and we thank him for the wealth of experience he brought to the Committee.
- The Cairns Regional Council Finance team for their work on TTNQ's financials.

The TTNQ 2020/2021 Annual Report and financial report were made available to members on the TTNQ corporate website from September 2021.

The Company's auditor for 2020/2021 was Grant Thornton. Grant Thornton's independent auditor's report on the company's 2020/2021 annual financial report was again unqualified.



Grant Thornton Audit Pty Ltd have given notice of their intention to resign as auditors of the Company (under section 329(5) of the Corporations Act 2001) subject to ASIC consent and shareholder approval.

In accordance with section 328B(1) of the Corporations Act 2001, the Company has sought and obtained a nomination from a member for BDO Audit (NTH QLD) Pty Ltd to be appointed as the Company's auditors. The Board has endorsed this recommendation.

Subject to ASIC consenting to the resignation of Grant Thornton Audit Pty Ltd and Grant Thornton Audit Pty Ltd submitting a formal resignation to the Company, it is noted that the Company appoint BDO Audit (NTH QLD) Pty Ltd as auditors of the Company.

8. Chief Executive Officer's report

The CEO thanked Ken Chapman and Wendy Morris and their contributions as Chair over the past couple of years. The CEO presented his report with an accompanying PPT presentation, with key points:

- It has been a challenging and rewarding year for all, and for TTNQ it has been a record year in terms
 of expenditure and results in the areas over which we had control (AVE, website visits and social
 media posts)
- TTNQ maintained its share of Queensland nights, high net promotor score and member satisfaction level.
- The successful campaigns run during the year (Summer in the Tropics, Summer Lives On, Escape Winter to the Tropics, Ad hoc, Adventure) and record investment in the drive market, all of which will be built upon in years to follow.
- The See Great Leave Greater brand has been used extensively and consistently across domestic
 marketing campaigns and with our team pushing our brand messages into the international market,
 keeping the trade partnerships alive, in readiness for reopening of international borders. This brand
 will continue to be strengthened in the years beyond COVID-19.

- All members, particularly Champion members, who together with TTNQ, drove domestic arrivals into our destination and supporting thousands of jobs.

- The TTNQ Business Events team, working closely with Janet Hamilton at the Convention Centre, generating record leads and referrals.
