MINUTES OF THE 2022 ANNUAL GENERAL MEETING Thursday 20 October 2022 10.00am — 11.00am

Held in accordance with ASIC guidelines and Corporations Act at Shangri-La Hotel, The Marina, Cairns

1. Meeting opening

TTNQ Chair, Ken Chapman, declared the AGM open at 10:10am, welcoming: Cairns Regional Council Mayor, Bob Manning; Board directors; members; and guests.

Attendance and Proxies

The required quorum for the AGM is 10% of the financial membership eligible to vote, which is currently 182 members. Therefore, the required quorum is 18.
