MINUTES OF THE 2023 ANNUAL GENERAL MEETING Thursday 19 October 2023 10.00am — 11.00am

Held in accordance with the Corporations Act at The Benson Hotel, Cairns

1. Meeting opening

TTNQ Chair, Ken Chapman, declared the AGM open at 10.07am, welcoming Board Directors, members and guests.

2. Attendance, apologies, proxies

Apologies: Tara Bennett, Tourism Port Douglas Daintree and Joanne Parisi, MacDonnells Law.

Attendance and Proxies

The required quorum for the AGM is 10% of the financial membership eligible to vote, which is currently 186 members. Therefore, the required quorum is 19.

The final number of voting members attending the AGM was 19.

The number of proxy votes received was 39.

A quorum was declared with 58 voting members.

The minutes of the 2022 AGM were taken as read.

7. Chair's report

The Chairs' report was delivered with an accompanying presentation. The Chair recapped on the events of the year and acknowledged TTNQ efforts exceeding organisational KPIs, the team at TTNQ provided outstanding AVE, ROI & market share. The Chair presented the Financial Statement, recognising the reportable loss due to timing of grants. With a cash position of \$5M June 2023, so overall doing very well. The Chair discussed the advocacy to the Federal Government and lobbying, as key achievements during COVID secured TTNQ the additional funding of \$15M.

- The Human Resource Committee (HRC); Janet Hamilton as Chair; Wayne Reynolds as committee member.
- Roise Douglas, after 13 years at TTNQ and over 30 years in the industry.
- Cairns Regional Council, for their continued support.
- Mayor Bob Manning, who is a great supporter of TTNQ.
- Cairns Airport and Ports North

The TTNQ 2022/2023 Annual Report and financial report were made available to members on the TTNQ corporate website from September 2023.

8. Chief Executive Officer's report

The CEO gave a special thanks to Ken Chapman for his three years as Chair. CEO thanked the entire TTNQ board of directors and all the TTNQ members and industry.

The CEO presented his report with an accompanying PPT presentation, acknowledging the contribution and support of:

- Martina Neidig-Quinlan of TEQ for her support through COVID and it was Martina's support that brought a lot of funding to this region.



- TTNQ Board, with delays in the ITRP funding the board approved early expenditure to drive \$44M into direct international sales from campaign activity and to put on our six international PR agencies who have generated \$200M to positive press globally for this region.
- Richard Barker and team at the Cairns Airport for their leadership, the flight from Haneda is a game changer with the increase seat capacity coming in.

In closing the CEO urged all members to continue to support TTNQ in advocating for the region.
